Simplified Selective Process for hiring Foreign Visiting Professor, for a determined period, to solve a temporary need under the terms of Law No. 8.745/1993, art 2, V and with changes introduced by Law nº 9.849/1999, Law nº 12.425/2011 and Law nº 12.772/2012.

1.4 Registration Fee: R\$ 20.00 (twenty reais), to be credited to the National Account of the National Treasury, Banco do Brasil, code 153 163 152 37 288 837. This fee, once collected, will not be refunded under no circumstances.

1.5 At the registration, the candidate must present a copy of the "Curriculum Vitae", a copy of the proof of the requirements requested in this Notice; Copy of the passport; Registration form completed and signed and proof of payment of the registration fee.

1.6 The candidate must hold a Doctorate degree for at least 5 (five) years; To have scientific production compatible with the standards required by Capes for concepts 6 or 7 of the field in which the program is inserted, attested by the program by the average score for the last three years; Present a document from his/her home institution which says that is released from professional activities during the contract period. This document will be exempt from those who are not employed or retired.

1.7 Upon rejection of the registration, a reconsideration request shall be made to the probative authority of the decision, or appeal to the Postgraduate Chamber, all within 48 (forty-eight) non-extendable hours, of the disclosure of the registrations granted.

1.8 The term of the contracts is 1 (one) year, renewable for equal period up to the maximum time of 4 (four) years, and the fixed values according to specific rules contained in this Notice.

3 About the evaluation process:

3.1 The candidate will be evaluated in Proof of Degrees.

3.1.1 The candidate whose "Curriculum Vitae" does not meet the requirements established for the field of knowledge in which he / she is registered shall be eliminated from the simplified selection process.

3.1.2 The Proof of Degrees is classificatory, and will consist of the assessment by the examination board of the titles presented by the candidate in his / her Curriculum Vitae, according to what is described in item 3.1.1.

3.1.3 The candidate who obtains a final average equal to or greater than 7 (seven) will be considered approved.

3.2 Valuation table of titles (fractions of time over 6 (six) months will be counted as 1 (one) year):

GROUP I - Teaching activities:

Teaching activity in postgraduate teaching "stricto sensu": 02 points per year.

Orientations completed: Thesis - 02 points per thesis; Dissertation - 01 point per dissertation.

Participation in examining boards: PhD - 0.5 points each; Masters - 0.4 points each.

GROUP II - Bibliographic production:

Score attributed in accordance with the evaluation criteria set forth in the 2010 Triennial Evaluation Area Documents of the Coordination for the Improvement of Higher Education Personnel - CAPES, available at the <<http://www.capes.gov.br/>>, "link" Triennial Evaluation.

GROUP III - Other Activities:

Activity as a consultant or member of the editorial staff of scientific journals in the area: with Qualis A1, A2 and B1 - 01 point per period; With Qualis B2, B3, B4 and B5 - 0.5 points per period.

Award of professional or academic merit: of international scope - 02 points; Of national scope - 01 point.

3.3 The highest score achieved by a candidate will receive the grade 10 (ten).

3.4 To obtain the notes of the other candidates will be used the rule of three simple and direct.

4 Remuneration:

4.1 The Visiting Professor's remuneration will be composed of the basic salary, set for level 1 of the Class D - Associate 1 of the teaching career, plus the Remuneration for Doctorate Degree plus Food Aid, observing

the work regime foreseen in this notice, and Law 12772/2012, and the Normative Guideline SRH / MP 5 of 2009: R\$ 14.679,91 (Current value since March 1, 2015) + Food Aid R\$ 458.00.

5 General Provisions:

5.1 The contract may be revoked by the institution, according to Article 4 of Law No. 8.745/1993 and its updates.

5.2 The visiting professor, at the end of the contract, must present a detailed report of the activities developed, either for closure or for renewal, in any situation approved by the program collegiate.

5.3 The contracting, under the terms of Art. 6 of Law 8.745 / 1993, of is prohibited.

5.4 The candidate who is a professor of Superior, Basic Education, Technical and Technologic of Federal Institutions, or employees of the direct or indirect Administration of the Union, the States, the Federal District and the Municipalities, as well as employees or servants of its subsidiaries and controlled companies, shall not be hired under the Law nº 8.745 / 93.

5.5 Candidates who have already had a contract under the Law nº 8.745 / 93, including as Substitute or Visiting Professor, may not be hired again under this Law, before the expiration of twenty-four (24) months of the end of their previous contract.

5.6 It is responsibility of the Foreign Visiting Professor to take the necessary steps to obtain the entry visa in Brazil, in the category corresponding to the activities that will be developed, with validity compatible with the period of stay in Brazil, including the possibility of extending the length of the contract, in accordance with current legislation.

5.7 The visiting professor may not receive assignments, functions or charges not provided for in the contract, nor may he/she be appointed, even if in a precarious or substitutive position (Article 9, subsection I and II of law nº 8.745 / 93).

5.8 The validity of the Simplified Selective Process shall be 01 (one) year, from publication date of the result homologation in the Official Federal Diary.

5.9 At the time of issue of the contract the candidate must present the proof of the qualification requirements disposed in this Notice and the documents requested for the hiring, found at <http://prodegesp.ufsc.br/>, link Public Contests - Selective Processes.

6.0 Publication of the final result of the selection process in the Official Federal Diary shall be valid as a supporting document of classification.

6.1 The applicant's registration will imply knowledge and tacit acceptance of the norms and conditions established in this Notice, in relation to which he cannot claim ignorance.
